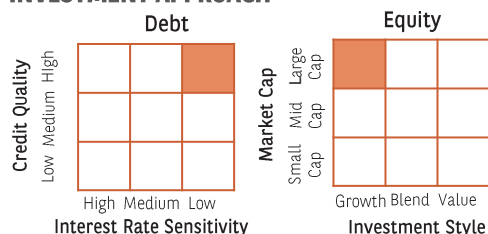

ABOUT THE FUND

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation.
- The funds strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market instruments.
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities.
- The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed taking into account the business fundamentals, the company's financial strength, industry structure, management quality, future earnings expectations and sensitivity of earnings.
- The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.

PORTFOLIO POSITIONING

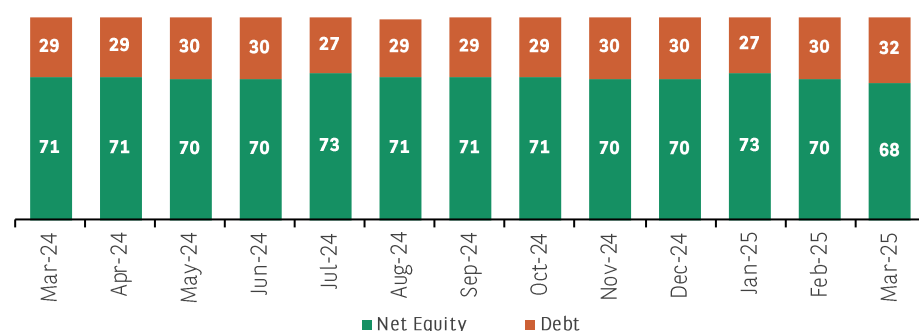
Equity:

- The 65:35 hybrid index was up 460bps for the month of March-25 led by a sharp bounce in equities which was up between 700-900bps (large cap - small cap). This was almost a clawback of the down move of 720bps witnessed in February-25.
- The fund ran an equity exposure of ~68% marginally lower than the prior month. Large caps exposure is up sharply to 76% (~250bps over the prior month) of overall equity exposures. REIT's and INVIT's accounted for ~1.25% with the balance across debt investments.
- In the month of March-25, we added to certain exposures in industrials and energy. We trimmed certain exposures in financials (mainly NBFC's), utilities and in IT with the cut in exposures being marginally ahead of the adds.
- From a cap curve perspective, the accretion to large caps of ~250bps was done by an almost equivalent cut in mid and small caps given the better risk return trade-offs in large caps.

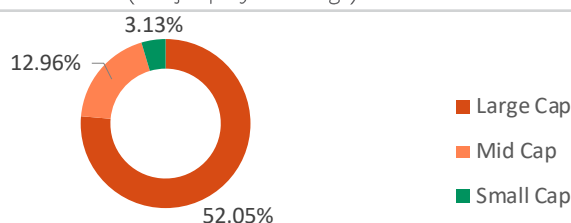
Debt:

- The weighted average overnight Rates eased by 50bps from 6.60%-6.65% in February-25 to 6.10-6.15% in March-25.
- The liquidity deficit has seen a slow decline in March-25, compared to peak deficits later this year. However, it turned into surplus at the month end due to huge government spending and OMOs.
- RBI's forward guidance and the rate cut gives us confidence on growth supported future policy expectations.
- We remain invested in small amounts in AAA REITS, INVITS and PTCs with an intention to generate alpha over debt returns from a medium-term perspective.
- We intend to run duration in the range of 2.50yr-3.50yr years basis current interest rate view
- The scheme remains open to tactical duration calls apart from maintaining a reasonably attractive carry through corporate bonds.

HISTORIC NET EQUITY ALLOCATION (% of Net Assets)

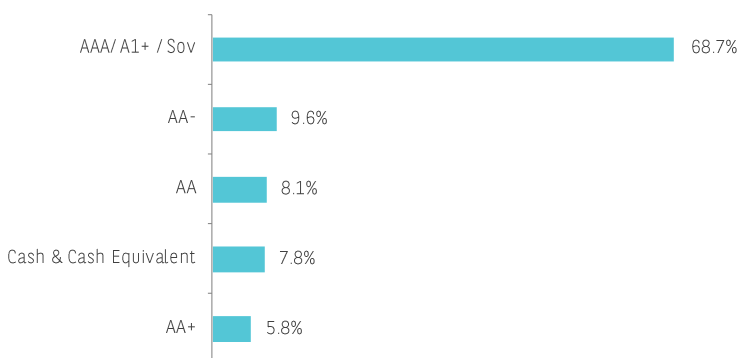


CURRENT MARKET CAP (% of Equity Holdings)

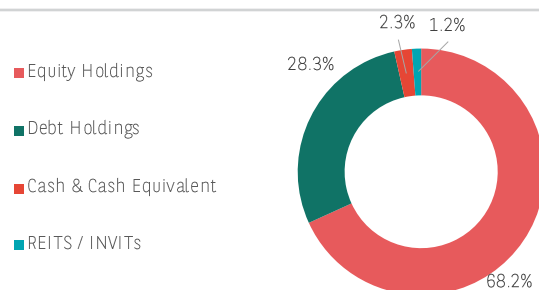

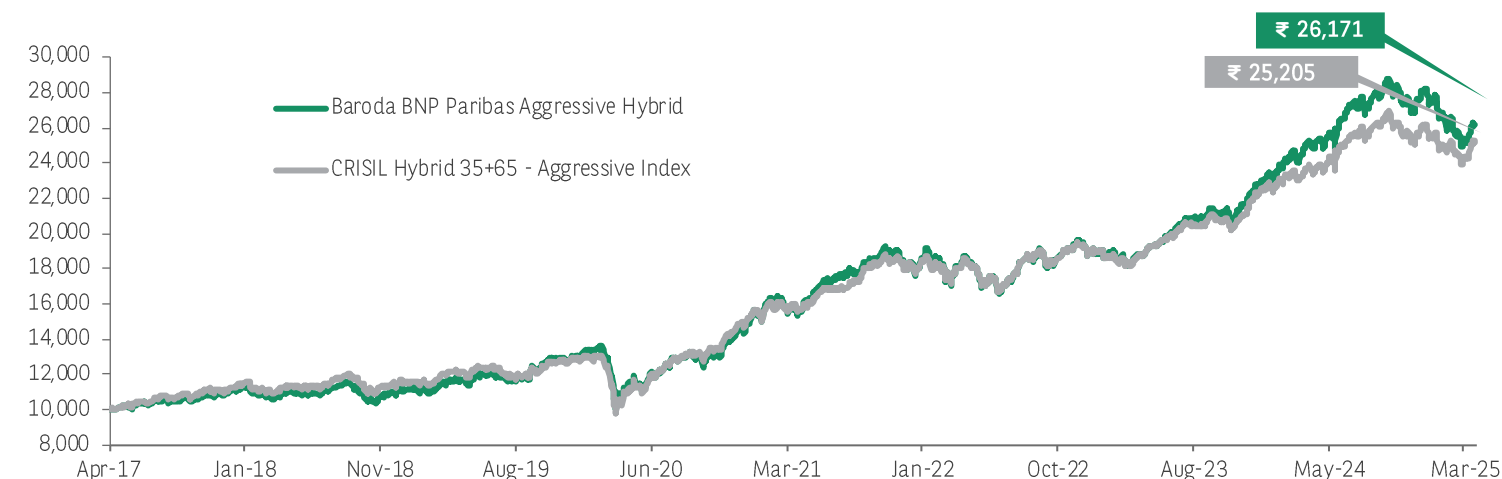

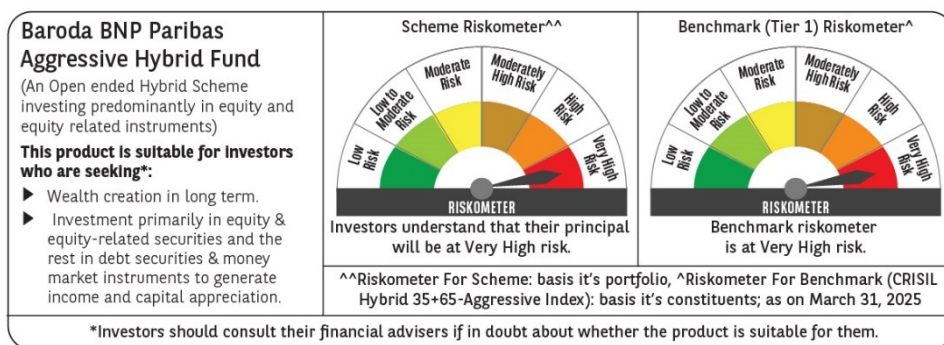

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond. As it provides a way to estimate the effect of certain market changes on a bond's price, the investor can choose an investment that will better meet his future cash needs.
