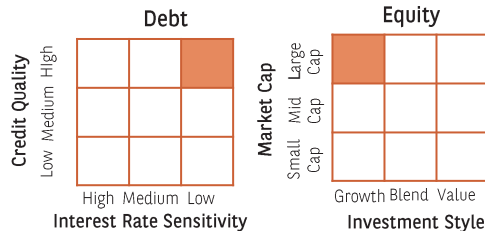

ABOUT THE FUND

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation.
- The funds strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market instruments.
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities.
- The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed taking into account the business fundamentals, the company's financial strength, industry structure, management quality, future earnings expectations and sensitivity of earnings.
- The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.

PORTFOLIO POSITIONING

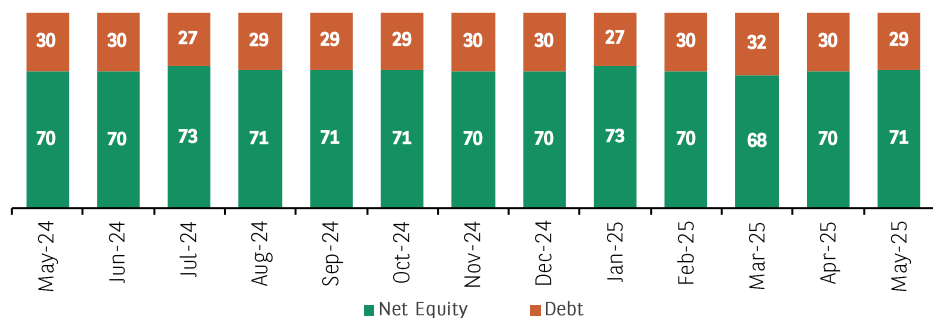
Equity:

- The 65:35 hybrid index was up 161bps during the month of May making it 3 months of up-move on the trot. Though the month began on a nervous note due to the Indo-Pak border hostilities, the announcement of ceasefire led to an uptick in markets with the equity component rising 750bps. Fixed income consolidated post the run on RBI easing monetary conditions.
- The fund ran an equity exposure of ~68.1% - down 110bps from the prior month due to some profit booking post the three months of strength in equities. This was funded almost entirely by some profit booking on large caps. We had also created some cash for certain IPO's towards the month end. Large caps accounted for nearly 75% of the total equity exposure ~250bps lower than the prior month. REIT's and INVIT's were virtually static at 1.23% month on month with the balance across debt instruments.
- With the rebound in markets, we added to certain positions across consumer discretionary & industrials. We marginally trimmed financials weights (~100bps) mainly on some selective profit booking.

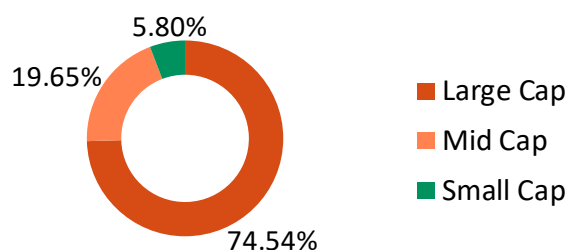
Debt:

- RBI's forward guidance and the rate cut gives us confidence on growth supported future policy expectations.
- Recent softening in domestic inflations paves the way for RBI to take calibrated policy decisions.
- Having said that external headwinds continue weigh on INR which will have spillovers over domestic liquidity.
- We intend to keep the duration of the fund in the range of 3.50 years - 4.50 years as per basis interest rate view and fund mandate.
- We remain invested in small amounts in AAA REITS, INVITS and PTCs with an intention to generate alpha over debt returns from a medium-term perspective.
- The scheme remains open to tactical duration calls apart from maintaining a reasonably attractive carry through corporate bonds.

HISTORIC NET EQUITY ALLOCATION (% of Net Assets)

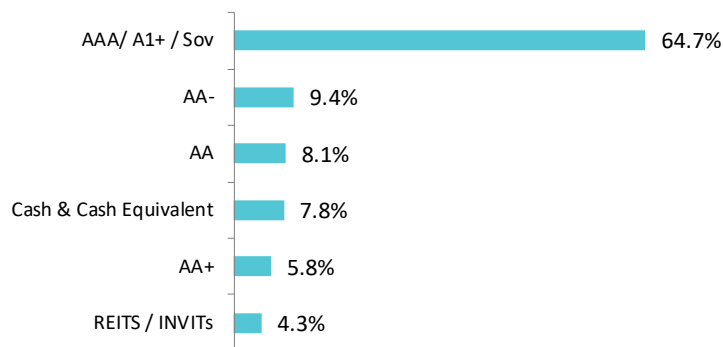


CURRENT MARKET CAP (% of Equity Holdings)

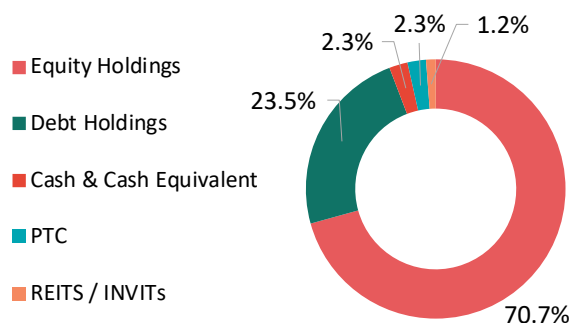

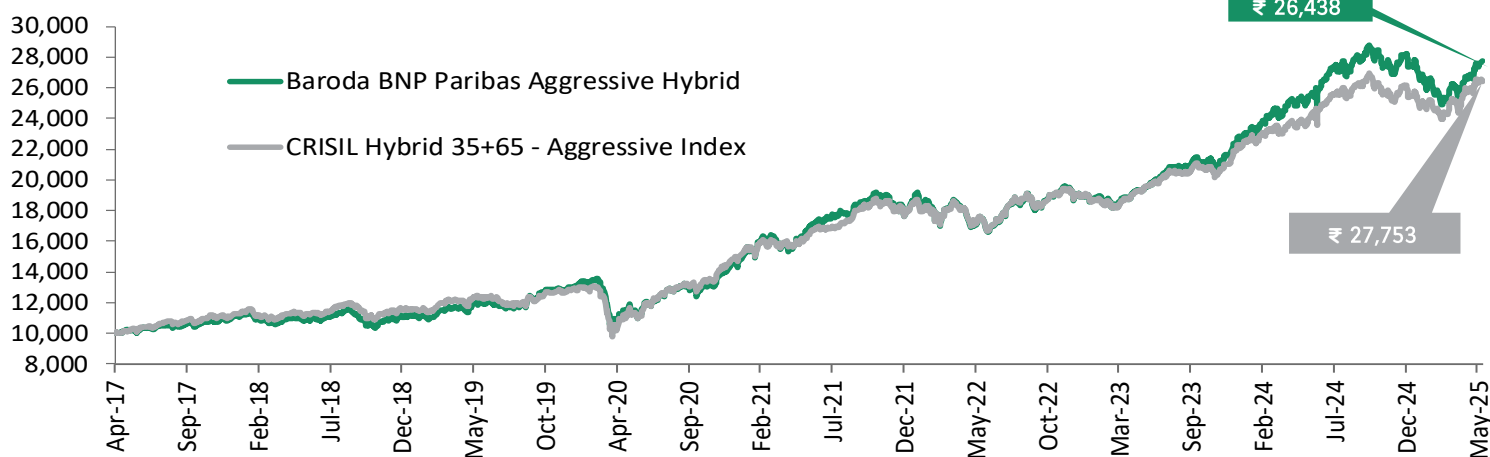

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond.
