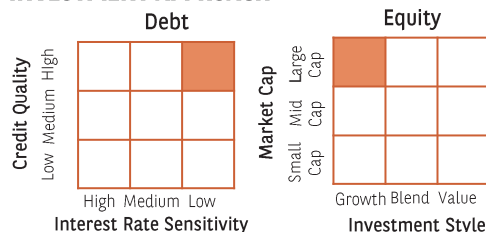

ABOUT THE FUND

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation.
- The fund's strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market instruments.
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities.
- The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed taking into account the business fundamentals, the company's financial strength, industry structure, management quality, future earnings expectations and sensitivity of earnings.
- The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.

PORTFOLIO POSITIONING

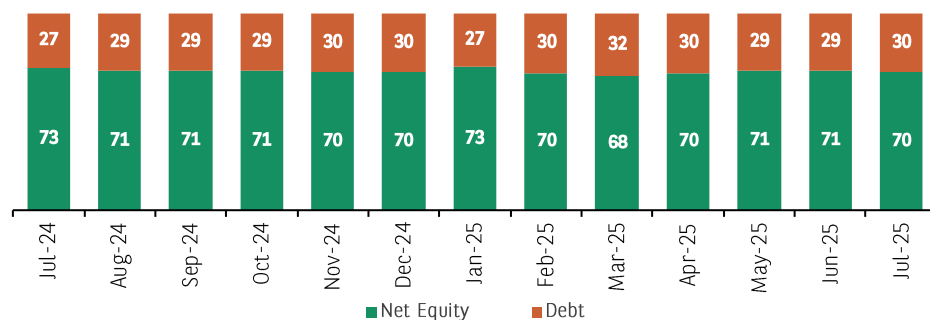
Equity:

- The 65:35 hybrid index was down ~164bps for the month of July. The equity component retreated 304bps implying positive performance on the debt component.
- The fund ran an equity exposure of ~69.9% which was flat on a month-on-month basis. REIT's & InvIT's jointly account for 1.3% with the fixed income accounting for the balance. Within the equity component, 67.1% comprises large caps with the SMID space accounting for the balance. This is lower than the prior month by ~500bps as we have added to SMID exposures and trimmed some large caps. Some part of the reduction in large cap exposures is also attributable to the AMFI reclassification with effect from July.
- The incremental exposures were largely in the financials space (~200bps) with materials (~100bps) and industrials (~30bps) accounting for the balance. These were funded largely by trimming on consumer discretionary (~90bps), utilities (~60bps) and energy (~40bps).

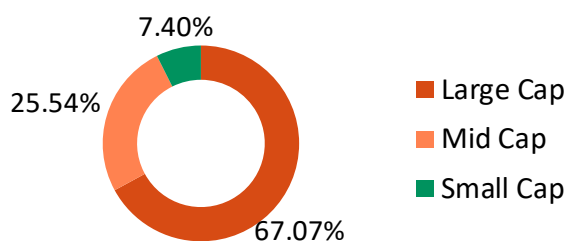
Debt:

- While the RBI has continued to conduct VRRR auctions, the weighted average overnight Rates have continued to trade below repo rate due to surplus liquidity.
- We expect liquidity to remain surplus even after to maturity of \$5Bn Fx Buy/sell swap and the indirect tax and GST outflow.
- Neutral Stance by RBI indicates the market that the operational overnight rate may remain closer to repo rate.
- Recent softening in domestic inflations paves the way for RBI to take calibrated policy decisions and continue to be pro-growth in terms of monetary policy actions.
- We intend to keep the duration of the fund in the range of 3.50 years - 4.50 years as per interest rate view and fund mandate.
- In addition, we remain invested in small amounts in units of REITS, INVITS and AAA PTCs with an intention to generate alpha over debt returns from a medium-term perspective.
- The scheme remains open to tactical duration calls apart from maintaining a reasonably attractive carry through corporate bonds.

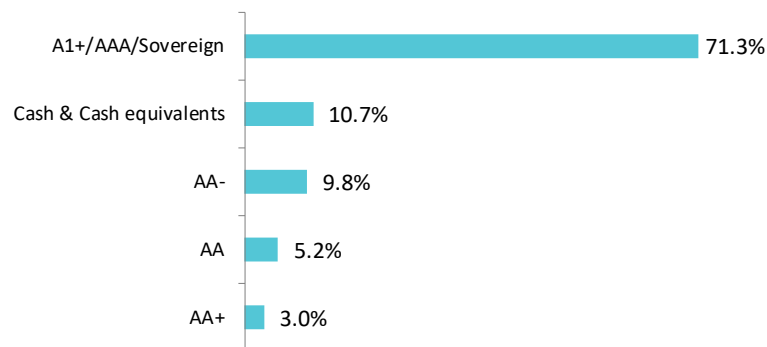
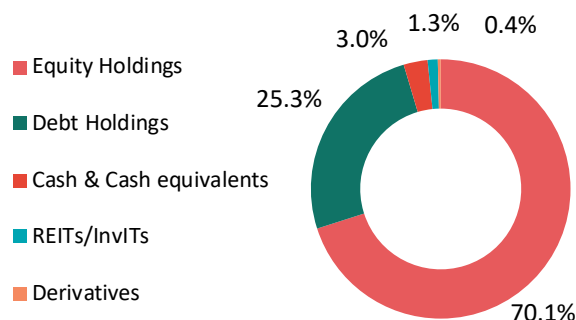
HISTORIC NET EQUITY ALLOCATION (% of Net Assets)

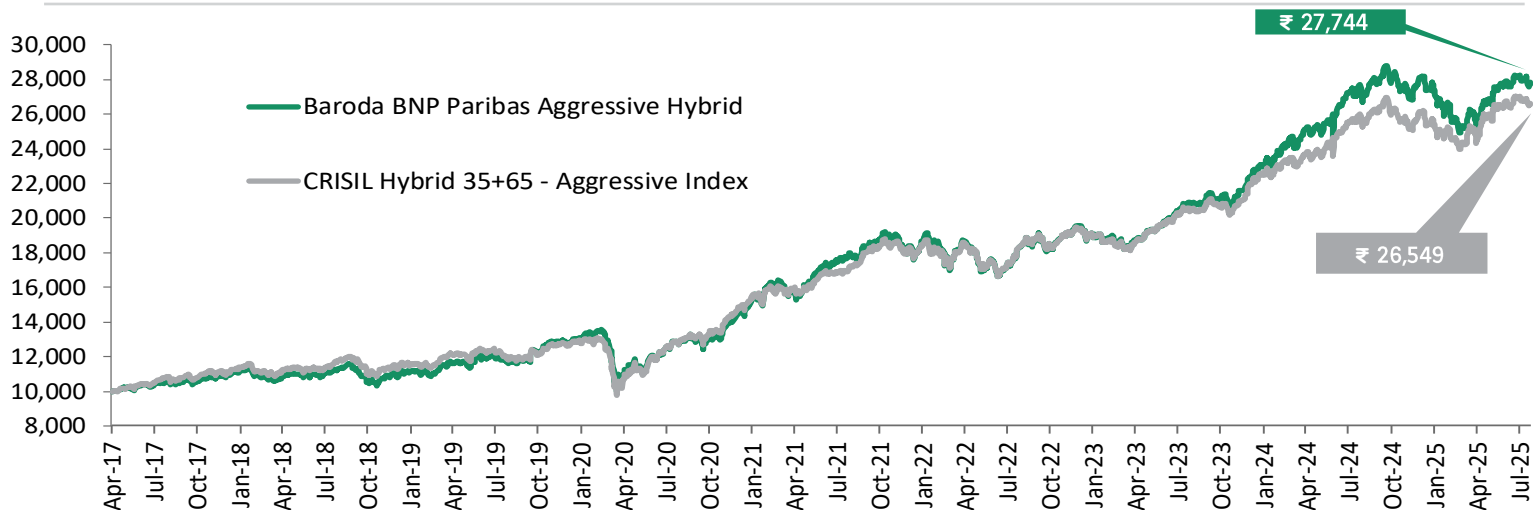

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond. As it provides a way to estimate the effect of certain market changes on a bond's price, the investor can choose an investment that will better meet his future cash needs.
