

### **ABOUT THE FUND**

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation
- The funds strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities

  The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed
- taking into account the business fundamentals, the company's financial strength, industry structure, management quality,
- future earnings expectations and sensitivity of earnings.

  The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.


### **PORTFOLIO POSITIONING**

### Equity:


- The 65:35 hybrid index rose by nearly 3.2% during the month with equity market rally driving the index. Equity investment levels are currently -69.4%, up by 170bps over the levels of the prior month on the back of the market rally. Across this equity component, -69% (up 100bps over the prior month) is in the large cap space and the balance across mid and small caps. Some part of the large cap addition was in the materials space compensated by some marginal cut in the financials space wherein we shuffled from certain large cap financials to mid cap ones given a large amount of acquisition activity there.
- REIT's & Invits continue to be ~1.3% of the portfolio while fixed income contributed the balance.
- On the back of the US Fed rate cut, which may prompt some weakness in the USD, we added to commodities exposure across materials (~60bps) and energy sectors (~30bps) cutting our underweight stance. We also added to certain financials exposures (~30bps). This was largely funded by cuts to industrials (~60bps) and consumer discretionary (~30bps) weights the user segments of
- We are now marginally underweight consumer discretionary, overweight on industrials and staples and neutral now on financials and energy

- The primary objective of the Scheme is to generate income and capital appreciation by investing in a diversified portfolio of equity and equity related instruments and fixed income instruments.
- The fixed income portion intends to keep the duration of the fund in the range of 3.50 years 4.50 years as per constructive interest
- To achieve the same, we have allocated in mix of ~35%-65% strategy in terms of GSEC: Corporate bond composition. The corporate bond exposure comprises of mix of AAAs (~80%) as well as some carry assets up to AA- (~20%) ranging from 2-5yr maturity to the get the accrual benefit of 70-200bps compared to GSEC.
- In addition, to enhance the accrual of the fund we continue to stay invested in AAA (SO) PTC's which also helps portfolio
- The recent selloff in the fixed income market has resulted in attractive entry point at long end of the Gsec curve, accordingly we have increased weightage to 30-40 yr sovereign bonds
- The Fund also intends to maintain its allocation to units of REITs/InVits to enhance the potential return of the fund
- Further, we will be open to taking tactical duration calls whenever opportunity arises

# **HISTORIC NET EQUITY ALLOCATION (% of Net Assets)**




**CURRENT MARKET CAP (% of Equity Holdings)**


