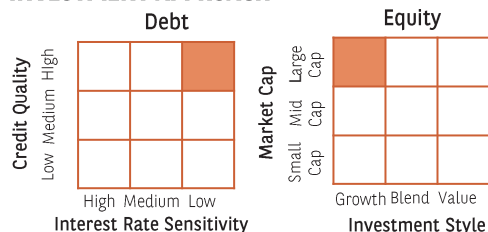

ABOUT THE FUND

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation.
- The funds strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market instruments.
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities
- The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed taking into account the business fundamentals, the company's financial strength, industry structure, management quality, future earnings expectations and sensitivity of earnings.
- The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.

PORTFOLIO POSITIONING

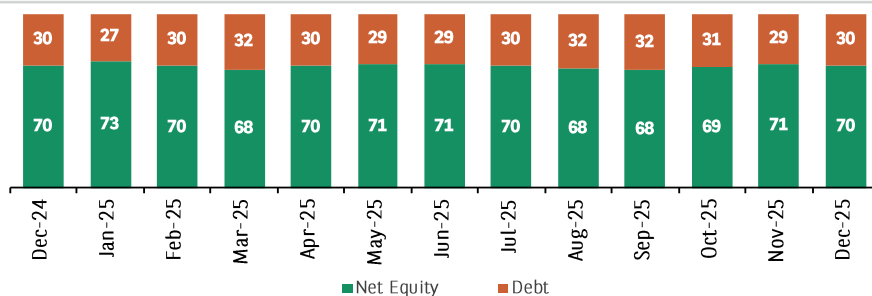
Equity:

- The 65:35 hybrid index fell during the month by 23bps led by the equity component falling 44bps and fixed income delivering the upside. Equity investment levels are currently ~69.4% similar to the prior two months. Within equity 66.5% comprises large caps - a 120bps reduction from the prior month with the increase in midcaps largely commensurate.
- From a sector standpoint we cut back on our underweight magnitude on IT as the sector appears to be showing signs of bottoming out. We also added to a commercial vehicles name to the portfolio on improving volumes. Within consumption we added to exposures across consumer services. These were largely funded by some profit booking in consumer retailing and some cut backs to our energy exposures.
- Post the recent re-classification on REITs/INVITs, INVIT exposures are now placed at ~0.75% while fixed income contributed the balance.

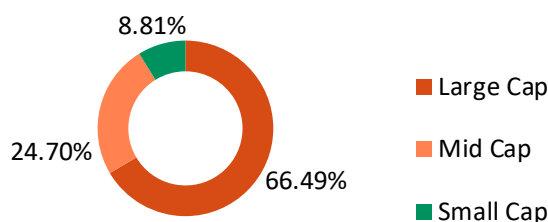
Debt:

- The primary objective of the Scheme is to generate income and capital appreciation by investing in a diversified portfolio of equity and equity related instruments and fixed income instruments.
- The fixed income portion intends to keep the duration of the fund in the range of 3.50 years - 4.50 years as per constructive interest rate view.
- To achieve the same, we have allocated in mix of ~30%-70% strategy in terms of GSEC: Corporate bond composition.
- The corporate bond exposure comprises of mix of AAAs (~80%) as well as some carry assets up to AA- (~20%) ranging from 2-5yr maturity to the get the accrual benefit of 70-200bps compared to GSEC.
- In addition, to enhance the accrual of the fund we continue to stay invested in AAA (SO) PTC's which also helps portfolio diversification
- The Fund also intends to maintain its allocation to units of REITs/Invits to enhance the potential return of the fund.
- Further, we will be open to taking tactical duration calls whenever opportunity arises

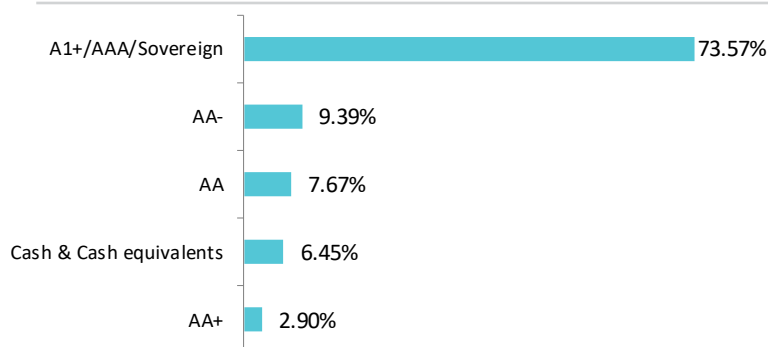
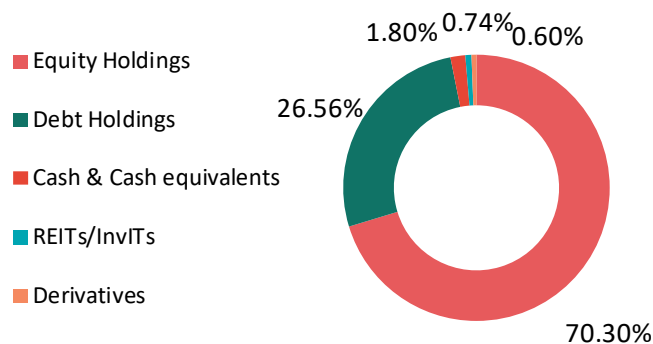
HISTORIC NET EQUITY ALLOCATION (% of Net Assets)

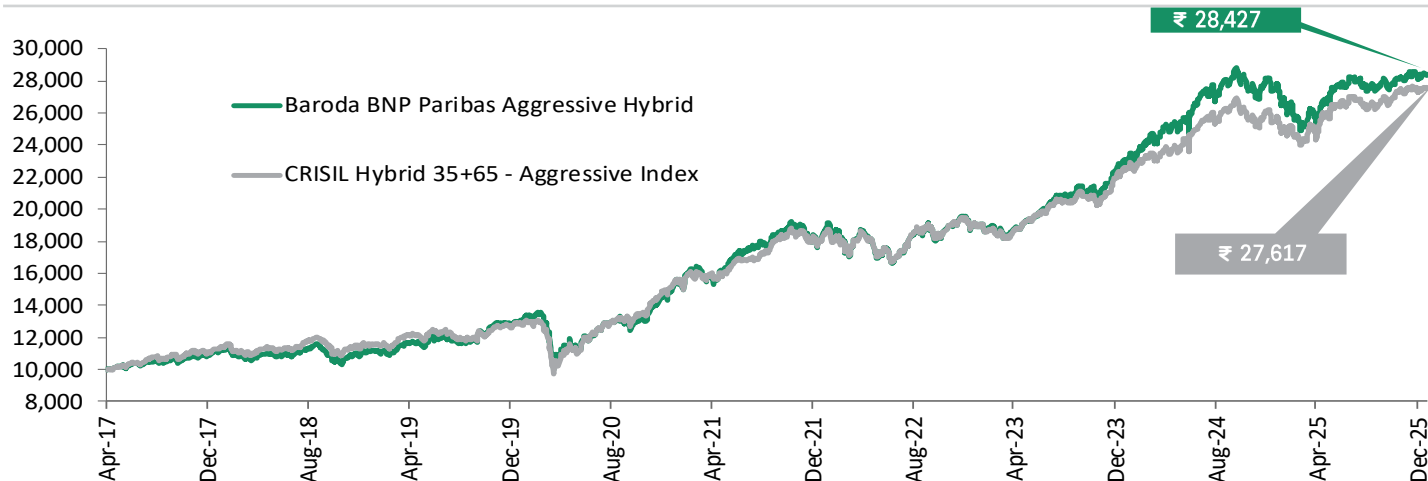

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond. As it provides a way to estimate the effect of certain market changes on a bond's price, the investor can choose an investment that will better meet his future cash needs.
