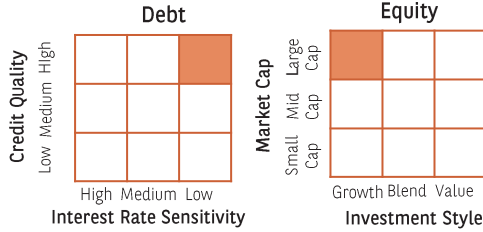

ABOUT THE FUND

- Baroda BNP Paribas Aggressive Hybrid Fund invests primarily in equity and equity related securities and also in debt and money market instruments to generate income and capital appreciation.
- The fund's strategy seeks to generate income and capital appreciation by taking advantage of diversification by investing in a mix of asset classes comprising equity & equity related instruments and fixed income securities including money market instruments.
- It also aims to manage risk through active selection within the specified asset allocation range. The aim is to improve risk adjusted returns through diversification across these asset classes.
- The equity portion of the portfolio aims to provide long-term capital growth through a diversified and actively managed portfolio of equity and equity related securities
- The focus would be to build a diversified portfolio of both value and growth companies, all companies selected will be analysed taking into account the business fundamentals, the company's financial strength, industry structure, management quality, future earnings expectations and sensitivity of earnings.
- The debt portion of the portfolio will be actively managed based on the AMC's view on interest rates. The price of fixed income instruments varies with changes in interest rates.
- This fund is suitable for investors looking for the advantage of capital appreciation and low volatility compared to other equity funds along with wealth creation in the long term.

PORTFOLIO POSITIONING

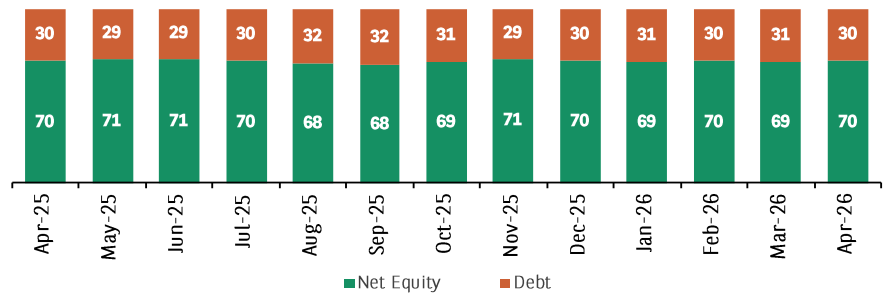
Equity:

- The markets showed a healthy rebound in April with the 65:35 hybrid index TRI rising 498bps after a sharp decline in March (West Asia crisis). Equity as an asset class rebounded while debt returns were subdued during the month.
- Crude oil still remains elevated posing tail risks for the market. We have therefore not actively added to risk assets and our equity weights inched up marginally by 59bps m-o-m to ~70.7%. Within equity too, two-thirds of assets are in the large cap space with SMID exposures contributing the balance third. This translates to an ~170bps reduction in large caps exposure.
- From a sector standpoint, we trimmed ~140bps of healthcare exposure (largely profit booking) and ~70bps each on financials and consumer discretionary exposures. These were used to fund additional exposures in industrials (~230bps) and consumer staples (~50bps).
- Our exposures into InVIT's has marginally fallen from 49bps to ~44bps m-o-m. Fixed income investments accounted for the balance.

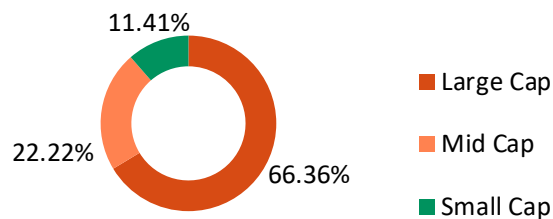
Debt:

- The primary objective of the Scheme is to generate income and capital appreciation by investing in a diversified portfolio of equity and equity related instruments and fixed income instruments.
- The fixed income portion intends to keep the duration of the fund in the range of 2.5 years - 3.50 years as per our current interest rate view.
- To achieve the same, we have allocated in mix of ~20%-80% strategy in terms of GSEC and Corporate bond composition.
- The corporate bond exposure comprises of mix of AAAs (~80%) as well as some carry assets up to AA- (~20%) ranging from 2-5yr maturity to get the accrual benefit of 70-200bps compared to GSEC.
- In addition, to enhance the accrual of the fund we continue to stay invested in AAA (SO) PTC's which also helps portfolio diversification
- The Fund also intends to maintain its allocation to units of InVits to enhance the potential return of the fund.
- Further, we will be open to taking tactical duration calls whenever opportunity arises. However core duration has been reduced from closer to 4 earlier to closer to 2.5 now

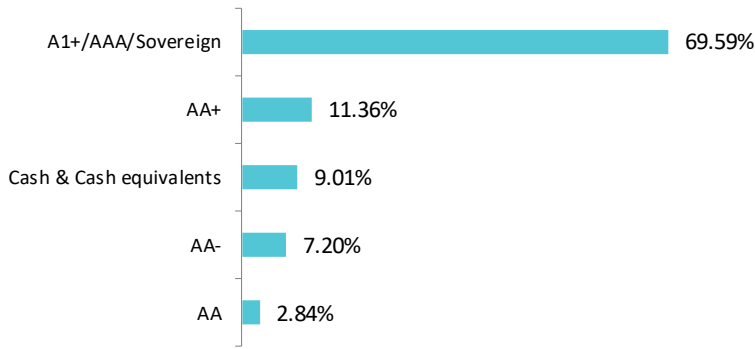
HISTORIC NET EQUITY ALLOCATION (% of Net Assets)



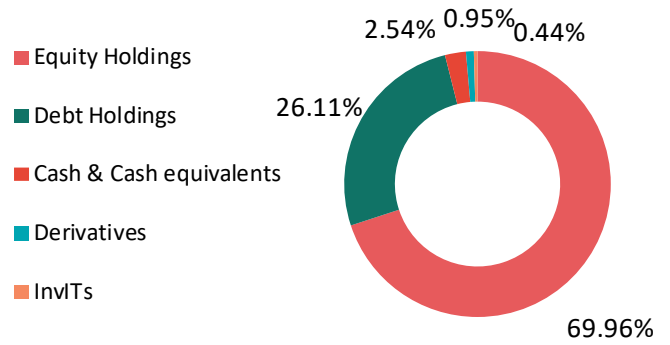
CURRENT MARKET CAP (% of Equity Holdings)

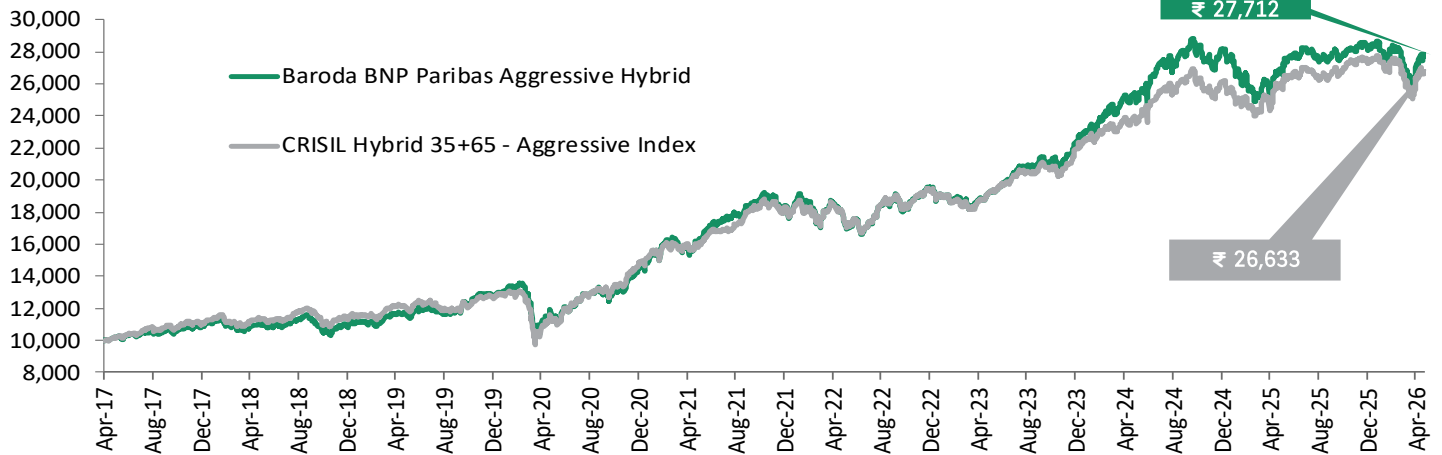

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price.
