ABOUT THE FUND

- Baroda BNP Paribas Arbitrage Fund aims to generate long-term capital growth primarily by using arbitrage strategy in equity markets and also invests a small component in short-term fixed income instruments.
- The portfolio will be managed using the arbitrage strategy by taking advantage from the price differentials in the spot/cash and derivatives segments of the market.
- The fund intends to benefit from the difference in pricing in cash and futures market. An arbitrage opportunity prevails when one buys a stock in the cash market and sells it at a higher price in the futures market so as to lock-in the potential gain.
- Fixed Income: Upto 35% would be invested in debt and money market instruments and/or units of debt schemes, including liquid, overnight, and money market funds.

PORTFOLIO POSITIONING

Derivatives Market

- The average rollover cost linked to the Oct-25 expiry ranged from 56 to 59 basis points.
- Nifty futures rollovers stood at 76%, in comparison to the 3-month average of 81%, which is a dip from the average over the past three months.
- The Nov-25 series of Nifty futures will initiate with a lower open interest of roughly 1.52 crore shares, in contrast to about 1.82 crore shares for the Oct-25 series.
- Bank Nifty Index futures rollover is approximately 80%, in contrast to approximately 79%, slightly above the three-month average.
- Market-wide rollovers are at 92% consistent with the 3-month average of 92%.
- Stocks rollover was recorded at 94%, which is in accordance with the 3-month average of 94%.
- As of Oct - 25, the domestic arbitrage book amounted to about ₹ 3,20,000/- Cr, which marks a small rise from ₹3,11,000 crore reported on Sep 25.

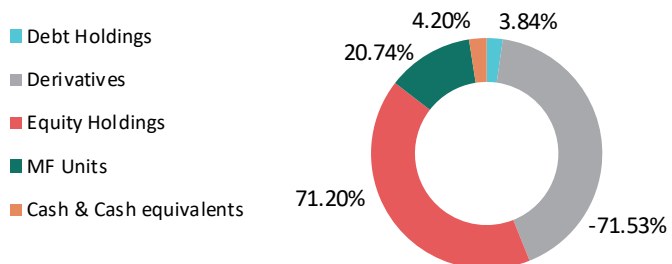
Equity Market Performance

- Nifty managed to wrap up the October series with gains close to 5.4%, succeeding three successive lacklustre expiries, representing the highest performance in the last sixteen monthly series. Bank Nifty ultimately closes with a gain of 6.5%.
- Outperforming sectors (Oct- 25) : Realty (+ 8.9%), Private Bank (+ 7.5%), PSU Bank (+ 7.5%), IT (+ 6.6%), Metals (+ 5.6%), Financial Services (+ 5.5%), Pharma (+ 3.7%), Defence (+3.5%), Oil & Gas (+3.3%), FMCG (+2.6%), Auto (+ 2.3%), Energy (+ 1.9%)
- Underperforming sectors (Oct- 25): Media (- 0.3%)

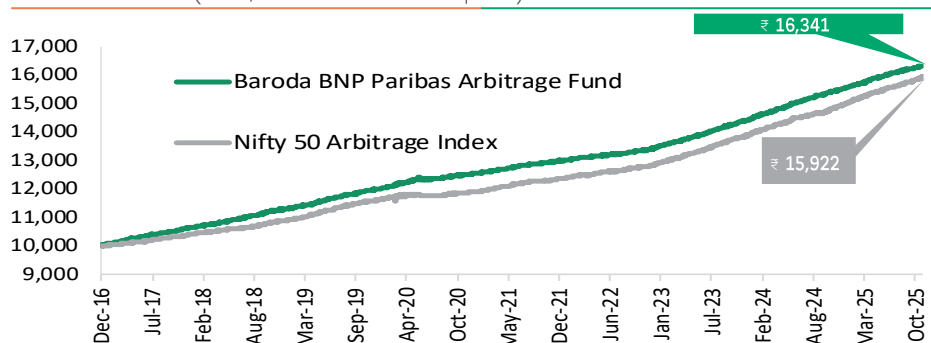

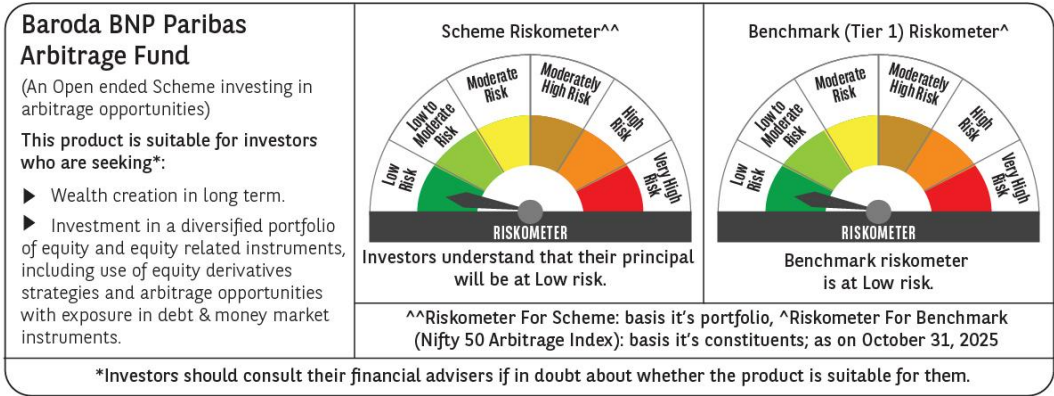

Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond. As it provides a way to estimate the effect of certain market changes on a bond's price, the investor can choose an investment that will better meet his future cash needs
