- The scheme is suitable for investors with a long term investment horizon.

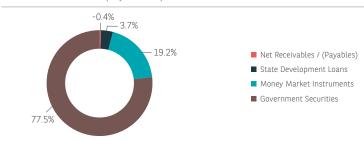
PORTFOLIO POSITIONING

- CPI Increase sharply to 6.52% in Jan 2023, the highest in three months, compared to 5.72% in December, and above
 market expectations of 5.9%, led by core inflation, food inflation, and unfavorable base effects.
- Tight liquidity conditions and supply pressure at the shorter end led by Banks and Corporates across the curve taking the levels higher by almost 20-30 bps making the curve flatter, 1 year T-bill also moved higher to 7.30 from 7.00
- We have increased the duration and we intend to run the duration of around 3.50 4.00 years.
- The scheme remains open to tactical duration calls.

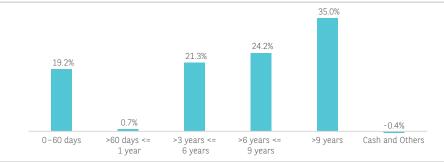
MACAULAY DURATION (in years)
