
#### **ABOUT THE FUND**

- Baroda BNP Paribas Focused Fund is an open-ended equity scheme with a multi cap portfolio of maximum 30
- A concentrated strategy may deviate significantly from the benchmark index and invest in a range of opportunities across market capitalization and sectors. Thus, the Scheme remains sector agnostic with the endeavour to add companies which may have high earnings growth potential.
- Alpha generation opportunity may be higher in a concentrated portfolio as the conviction and size of the stock bets remain high, albeit with high risk parameters associated with such strategy
- The scheme primarily follows a bottom-up approach for stock-picking. It uses a blended approach to build a portfolio of value and growth companies
- The core belief behind a concentrated strategy is to have stocks which are driven by strong fundamentals, which may grow at a faster pace than the economy or may have the ability to outperform the overall market. Select sector leaders and companies that are at the cusp of a turnaround are also likely to help alpha creation.
- The Scheme is suitable for investors who have a long term investment horizon.


#### **PORTFOLIO POSITIONING**

- Compared to the last month, we have increased exposure to Consumer Discretionary, Utilities, Health Care and Information technology. Exposure has been reduced in Financials, Energy and Communication Services.
- Key overweight positions are Consumer Discretionary, Industrials and Health Care, while key underweight positions are Consumer Staples, Materials and Financials.
- Mid and small cap exposure has increased to 39.6% from 38.5% a month ago. Large Cap exposure has reduced to 54.6% from 58.2% a month ago
- Cash position has increased to 5.9% from 3.3% last month.
- We are positive on the consumer discretionary sector as confluence of several factors (lower income  $\tan$ rates, lower interest rate environment, good monsoon and the recent GST cut) should help recovery in demand. While we are positive on auto and auto ancillaries, we are cautious on consumer electricals and FMS on valuations
- We remain overweight on Pharma and Healthcare. We are positive on market share gains and see robust outlook for hospital services driven by planned capex.
- We have increased Underweight on financials on valuations and utilities on weaker demand trends from
