
ABOUT THE FUND

 - Legacy Companies: Large businesses who are early adopters of new technology leading to innovation/disruption and transforming their companies as they respond to the changing market environment


PORTFOLIO POSITIONING

- Compared to last month, we have reduced exposure to Information Technology and Healthcare, while Increased exposure to Consumer discretionary and Materials.
- Key overweight positions are Consumer discretionary and Communication Services, while key Underweight positions are Financials, Energy and Consumer Staples.
- Mid and Small cap exposure stands at 59% (vs 53% last month). Large cap exposure stands at 37% (vs 42% Last month)
- Cash position stands at 4.4%.


