
- Baroda BNP Paribas Innovation Fund aims to invest in companies that benefit from Innovation.

#### **PORTFOLIO POSITIONING**


- Sector agnostic fund and stock selection led themes- innovator, enablers and legacy transformation cos.
- Compared to last month, we have reduced exposure Consumer discretionary, Healthcare, Industrials and Information Technology, while increased exposure to Energy and Financials.
- Key overweight positions are Consumer discretionary and Communication Services, while key Underweight positions are Utilities, Energy and Consumer Staples
- Mid and Small cap exposure stands at 60.4% (vs 58.5% last month). Large cap exposure stands at 31.97% (vs 36.9% Last month).
- Cash position stands at 7.6%.


