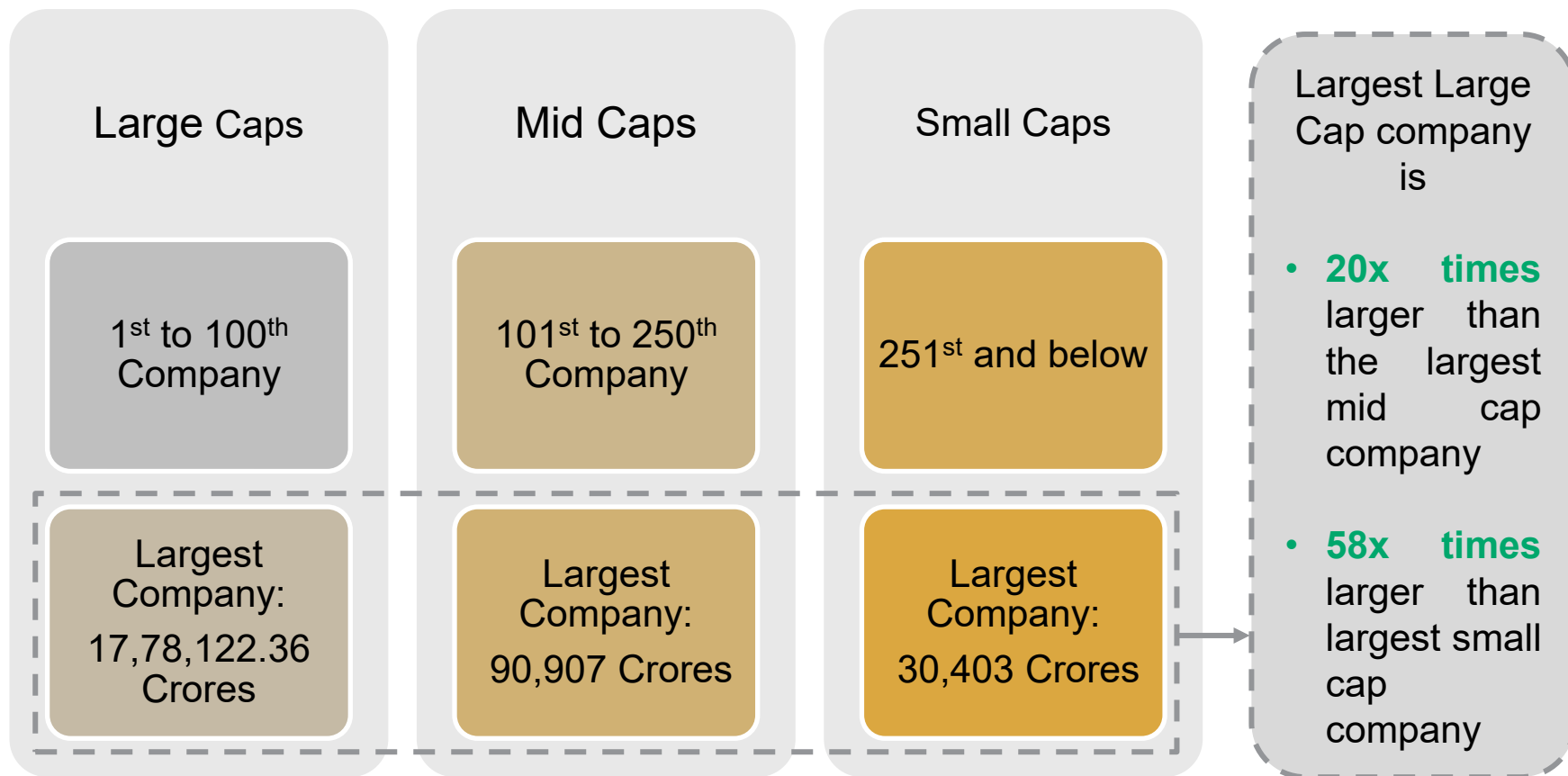

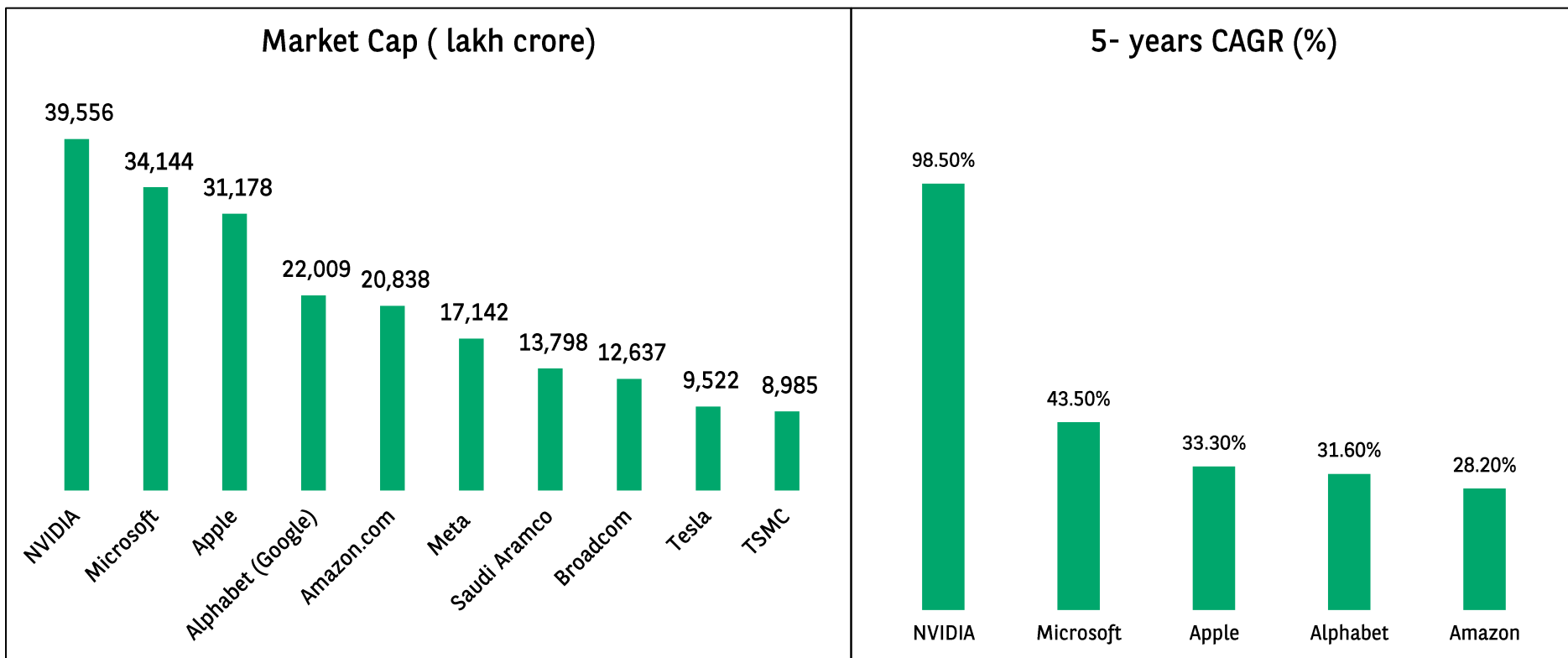

Large caps: Current theme!

Advantageous:

1. **Healthcare:** Advancements by Indian companies into new areas like GLP1, peptides etc. Tariff related disruptions could act as a short-term blip to the sector.
2. **Industrials:** Government enhancing capex to catch up on shortfall of earlier part of the year. Power and T&D remains a major area of spends. Also, signs of strong pick up in the public spends in this fiscal and Middle east export opportunities emerging for the select players in the sector.
3. **Utilities:** Rising energy demand; transition to renewables. Lately, the power demand has remained subdued due to early onset of monsoon and hence we are positioned towards base load producers than merchant power.

Neutral:

1. **Telecom:** Consolidation of competitive forces. Expectation of tariff increases and spectrum costs tapering off.
2. **Staples:** : More liquidity in the term of taxpayers through budget tax breaks, expectation of normal monsoon and thereby rural recovery to aid growth in the sector. During the month, trimmed 70 bps exposure to the sector due to changing regulations in certain subsegments
3. **BFSI:** Post RBI actions on creating liquidity, we have turned slightly constructive in the medium term keeping our stance as neutral. During this month, added further 80bps exposure to the sector due to softer inflation, higher liquidity being created by RBI and expectation of credit growth picking up.

Large caps: Current theme!

Dis-advantageous:

1. **Materials:** Weaker global growth could be a headwind on demand. Tariff protection could keep the sector in a limbo.
2. **IT:** Weakness in the DXY (dollar index) and headwinds of weaker than expected global growth amid the tariff uncertainties etc. Second order weakness could hurt tech spends. During the month, we have cut down 70 bps exposure to the sector due to H1B visa issues & slower growth.
3. **Consumer Discretionary:** Sign of certain slowdown in discretionary consumption which is making us near team cautious. We continue to observe a) recent tax breaks b) monsoon being normal as a boost to farm income c) pick up in the festive season in 2H to potentially change our stance on this space. Currently, underweight largely by way of limited exposures to consumer electricals and EMS spaces.

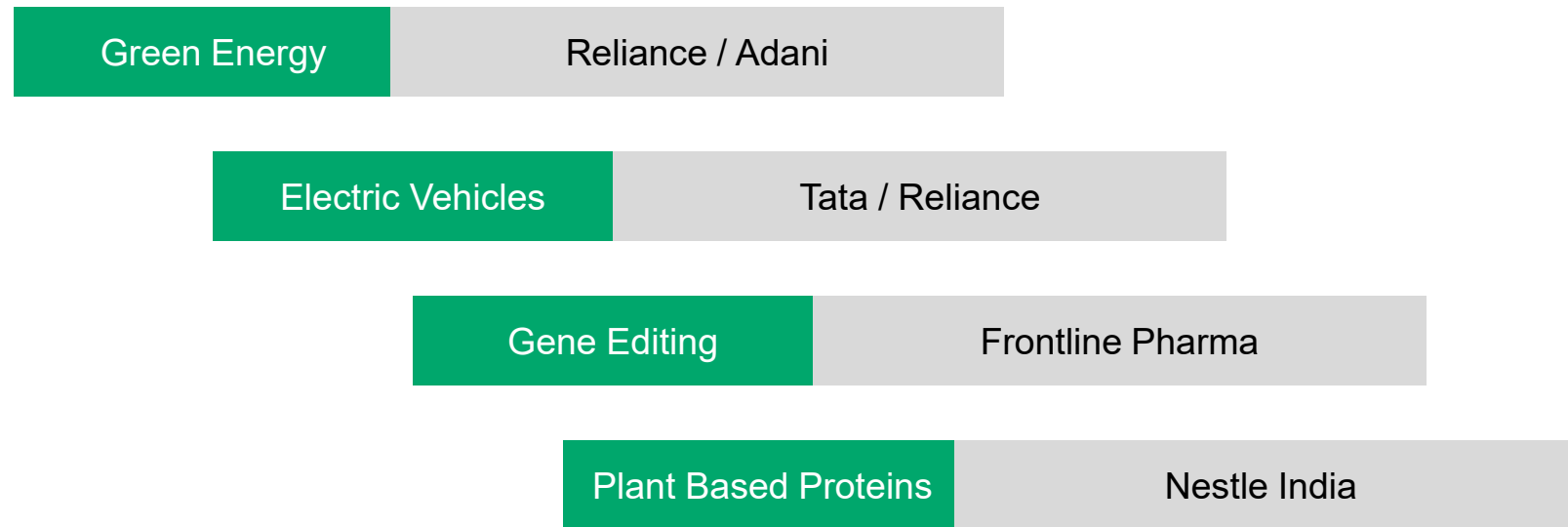

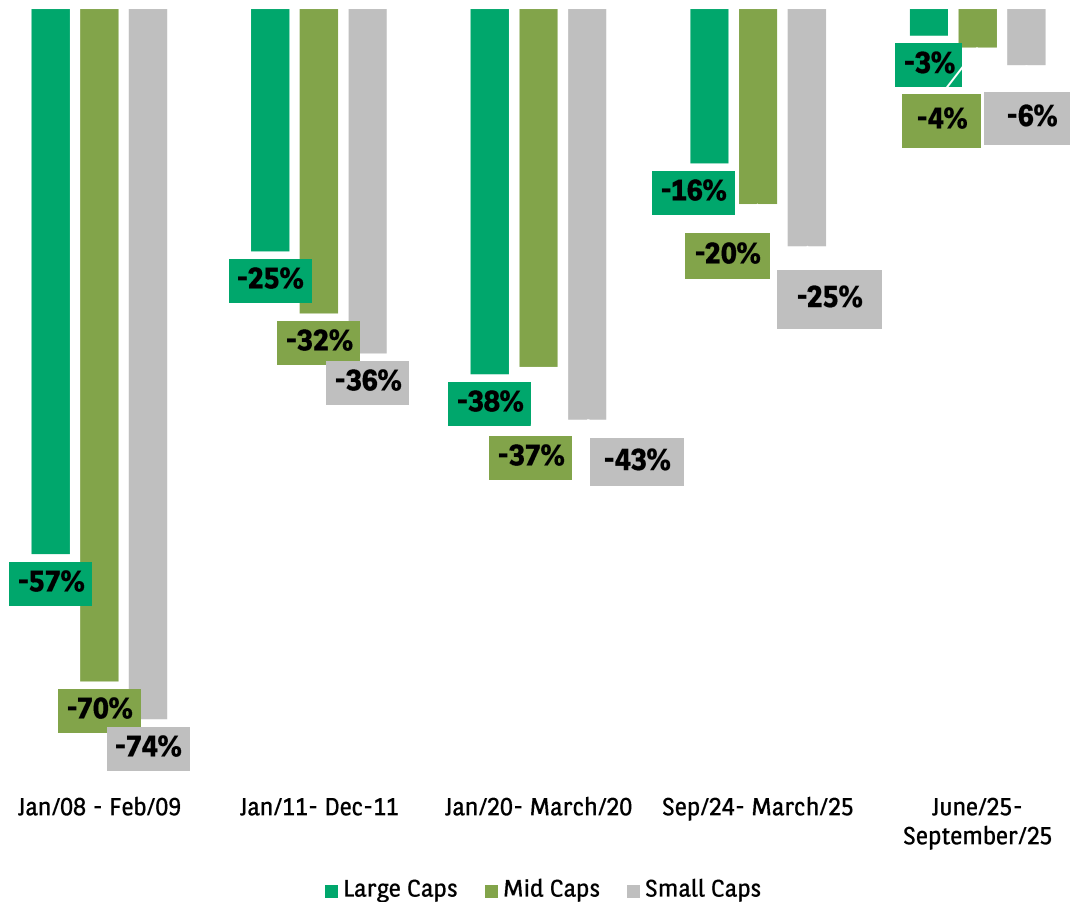

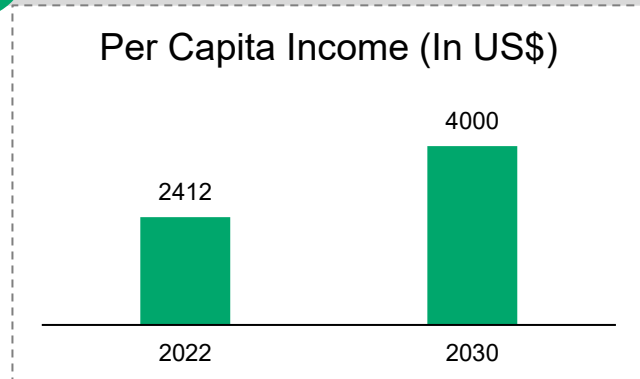

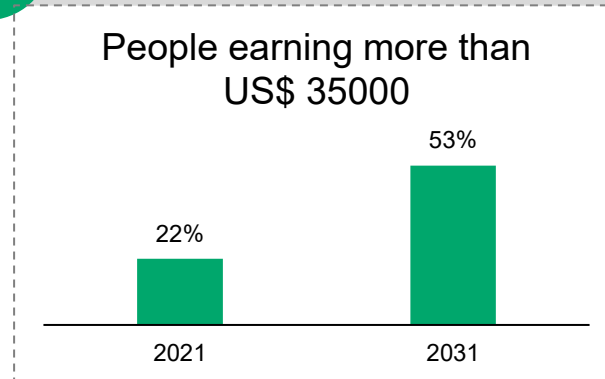
Increase in Per capita income

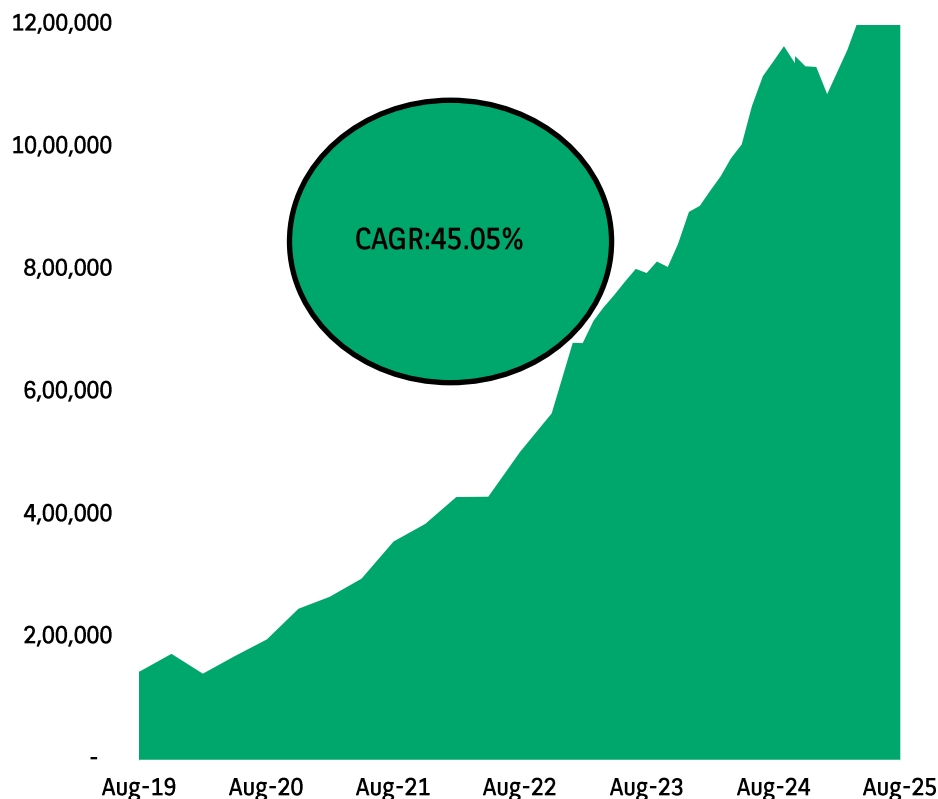

- With India's robust macros, strong GDP growth, India likely to attract higher foreign flows.

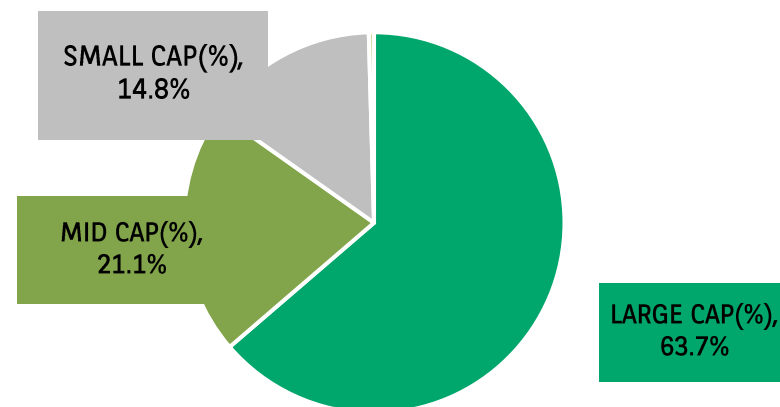

About the Fund

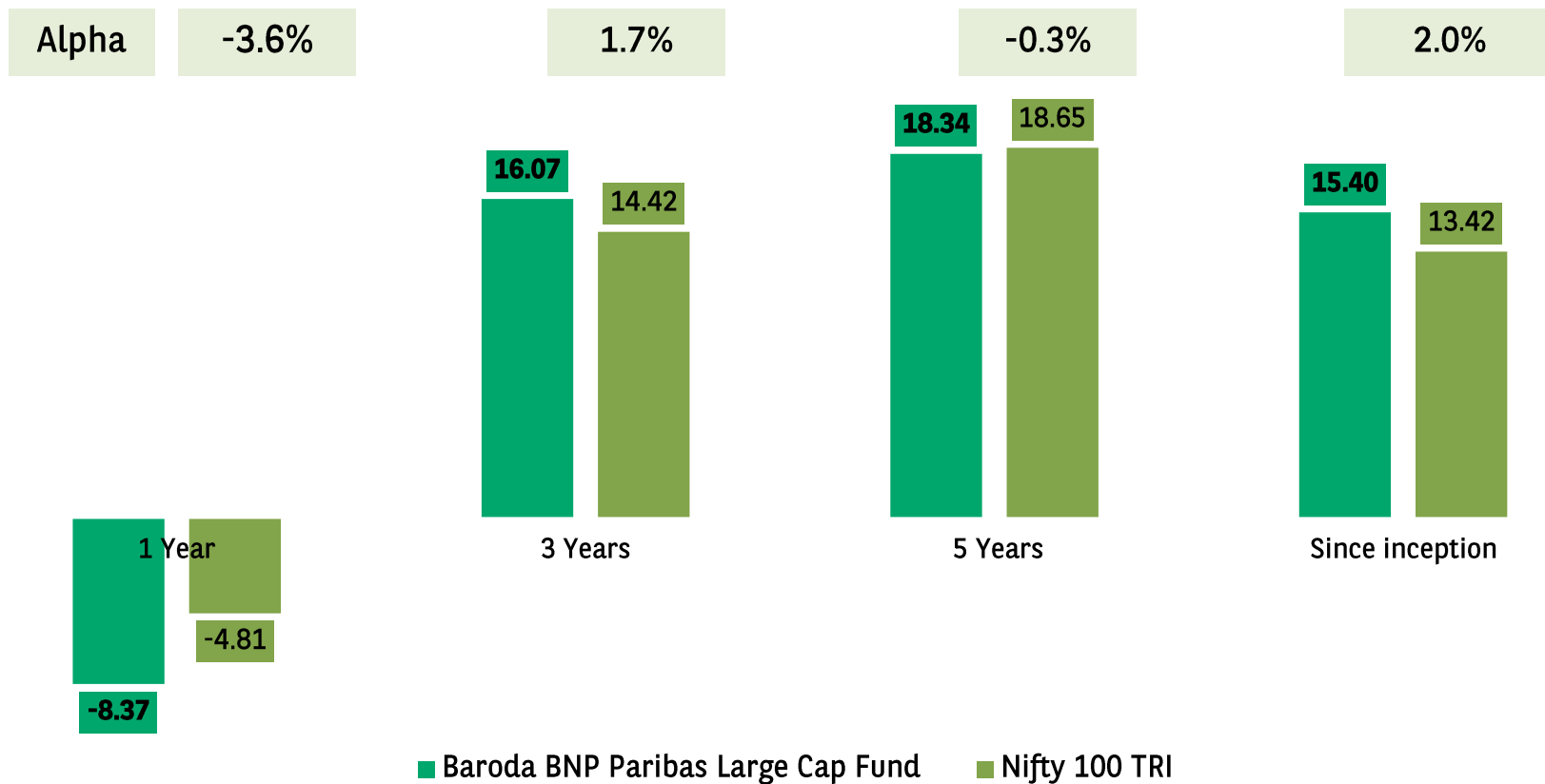
- Large cap funds typically invest in blue chip companies and market leaders which could generate stable revenue and earnings due to their established businesses and tenure.
- These companies being seasoned and large corporate houses, are likely to withstand market cycles. Mid or small cap companies tend to not have the same level of stability and therefore carry a higher degree of risk than large caps.
- Baroda BNP Paribas Large Cap Fund invests predominantly in such **large capitalization** companies with a **track record of growth in the long term**.
- The scheme intends to be well diversified across sectors and intends to focus on **quality names** exhibiting sound management and fundamentals with sustainable earnings growth potential.
- The scheme is suitable for **new and seasoned investors** who have a long-term investment horizon.

Overarching Philosophy

- Allocation more than Selection is a key determinant for success
 - 1) The Investment Universe is made up of India's largest and the most successful companies
 - 2) Basic hygiene Governance levels exist in all the companies
 - 3) Thesis are the most well researched and well tracked companies under constant scrutiny
- The Interplay of Macro-economics and their sectoral impacts is an important facet of allocating weights.
- Active shuffling of sectors based on our views on the economy (accelerating vs decelerating), and monetary conditions (hardening vs softening).
- Growth at a Reasonable Price (GARP) remains a key philosophy of selection of companies.

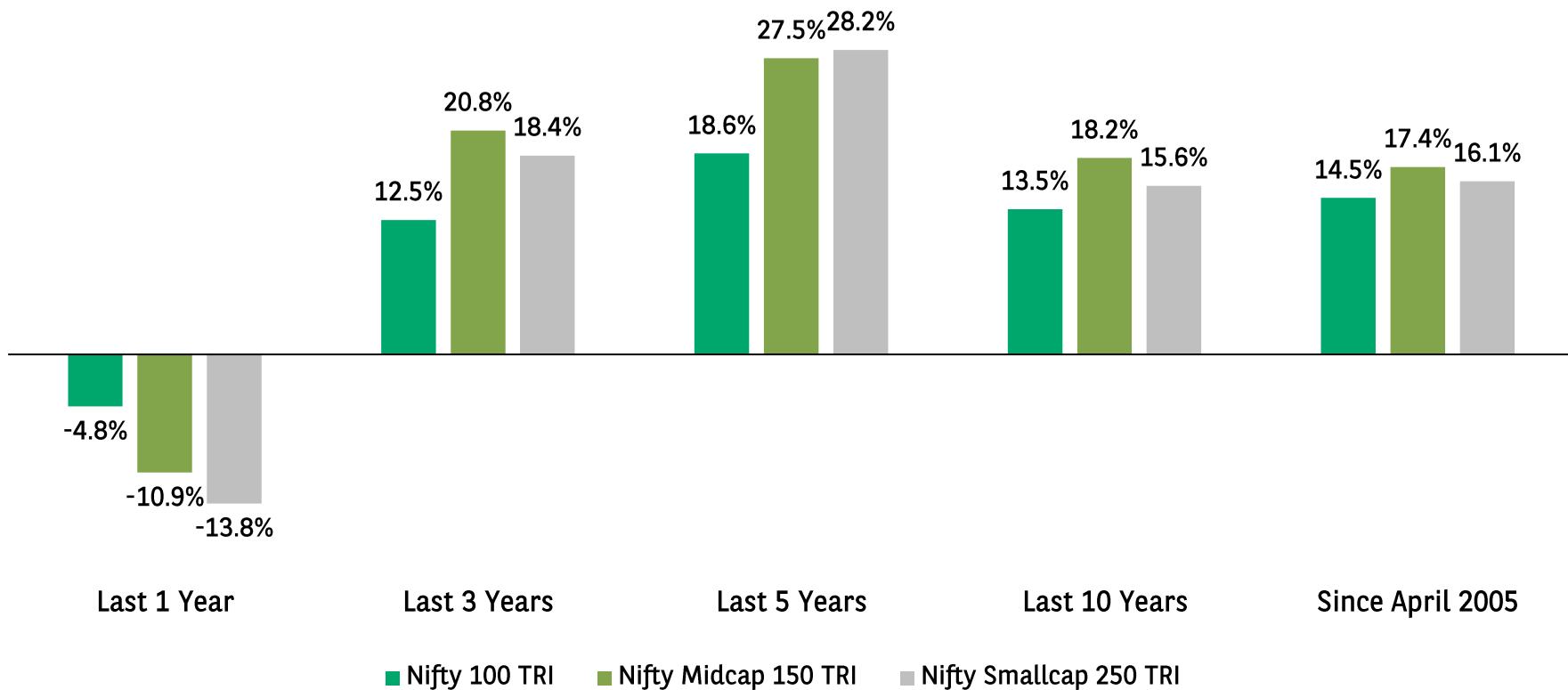

Fund Positioning

- Large cap indices showed a modest recovery in September rising 119bps. Though FII flows (which are typically clustered into large caps) saw outflows (-Rs189bn), domestic buying compensated.
- GST cut announcements, softer inflation prints and some buoyancy of an early festive season demand helped market sentiment over the month.
- The fund is currently invested to the tune of ~96% down 60bps from the prior month, largely a result of certain selective profit taking.
- We added to certain large caps across the financials (~80bps) and utilities space. These were funded largely by trimming IT services (70bps) and the healthcare space (30bps).

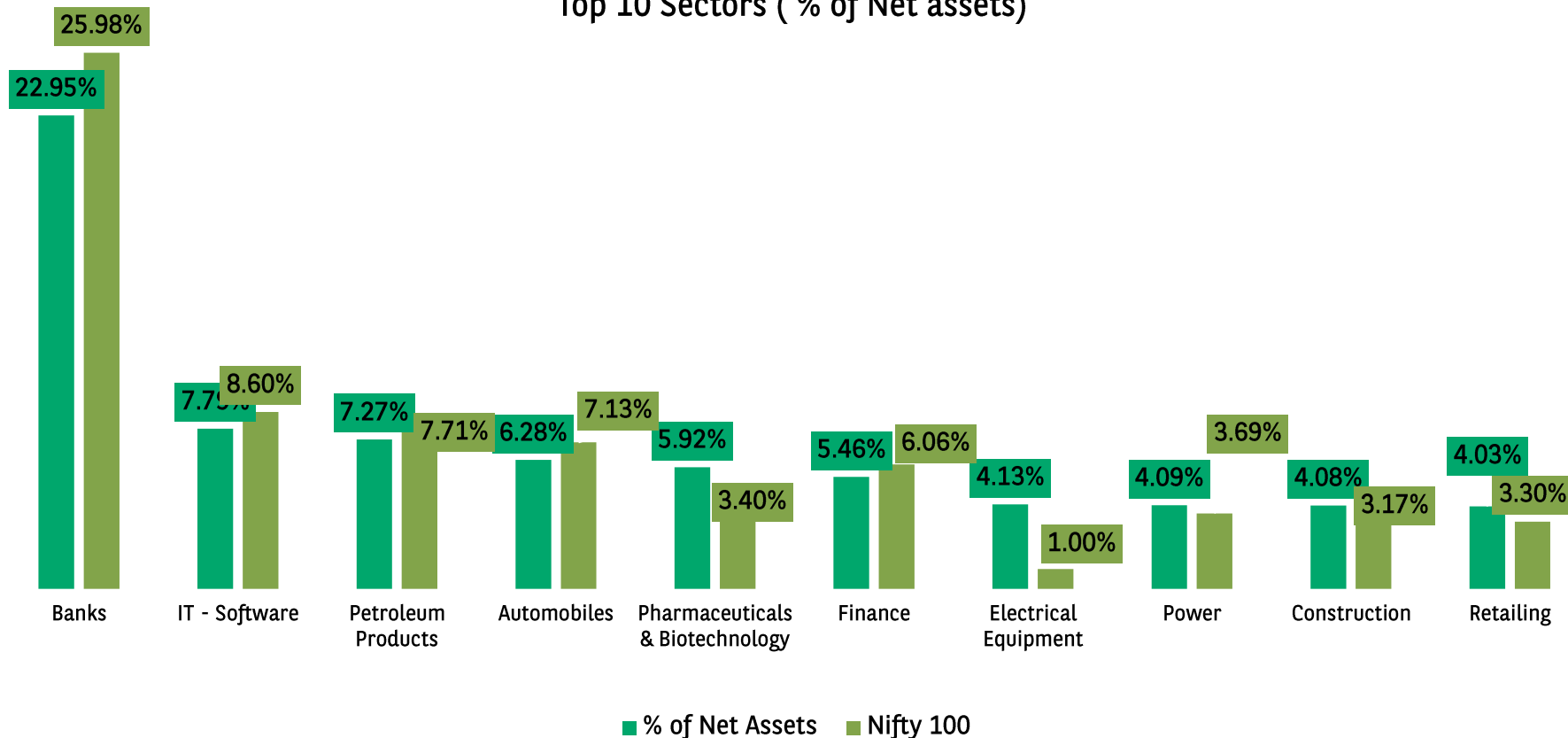

Top 10 Sectors (% of Net assets)

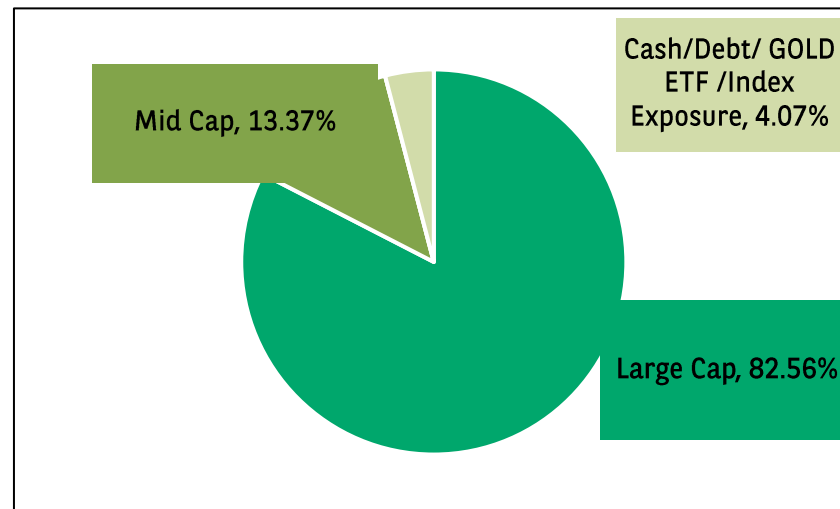

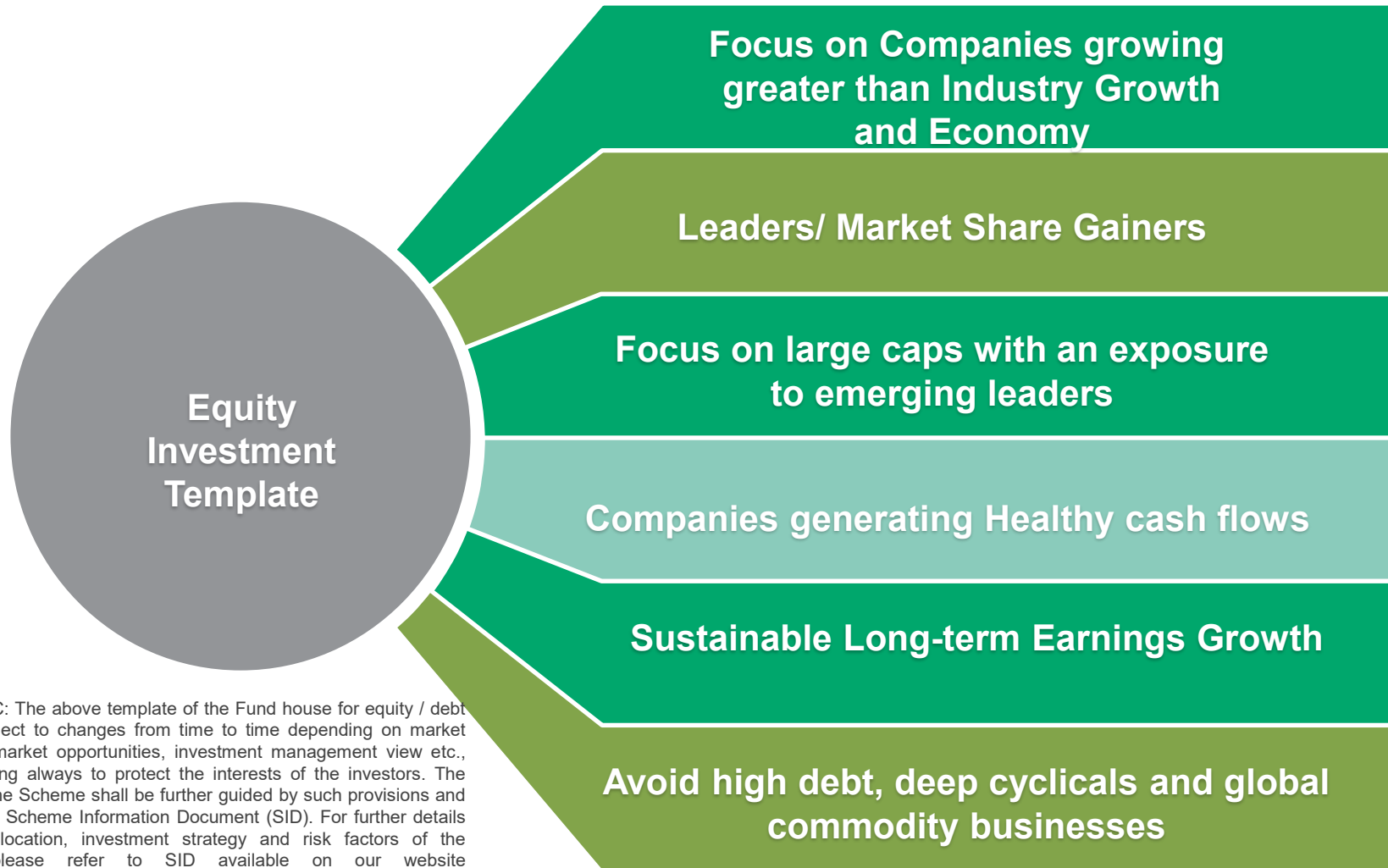
