

#### **ABOUT THE FUND**


- Baroda BNP Paribas Liquid Fund invests in debt and money market instruments with maturity of up to 91 days
- The fund primarily invests in short term debt instruments including treasury bills, certificate of deposits (CD), commercial papers (CP), Tri-party repo (TREPs) on CCIL platform with Government Securities as collateral/reverse repos, etc.
- The investment mandate of up to 91 days aims to reduce the sensitivity of the portfolio to interest rate changes
- As the scheme invests predominantly in money market instruments with high credit rating, the risk of default
  may be low. The scheme aims to offer twin advantages of low risk with high liquidity.
- This may be suitable for investors looking to park their idle or surplus money for a short term investment horizon.

#### **PORTFOLIO POSITIONING**

- While the RBI has continued to conduct VRRR auctions, the weighted average overnight Rates have continued to trade below repo rate due to surplus liquidity.
- We expect liquidity to remain surplus even after maturity of \$5Bn Fx Buy/sell swap and the indirect tax and GST outflow
- Neutral Stance by RBI indicates the market that the operational overnight rate may remain closer to reporate.
- Money market yield remained flat across the curve.


# RATING ALLOCATION TREND (% of Net Assets)




# **RATING ALLOCATION** (% of Net Assets) ASSE

\* Concept of Macaulay duration - The Macaulay Duration is a measure of a bond's sensitivity to interest rate changes. It is expressed in annual terms. It is the weighted average term to maturity of the cash flows from a bond. The weight of each cash flow is determined by dividing the present value of the cash flow by the price. Factors like a bond's price, maturity, coupon, yield to maturity among others impact the calculation of Macaulay duration. The Macaulay duration can be viewed as the economic balance point of a group of cash flows. Another way to interpret the statistic is that it is the weighted average number of years an investor must maintain a position in the bond until the present value of the bond's cash flows equals the amount paid for the bond. As it provides a way to estimate the effect of certain market changes on a bond's price, the investor can choose an investment that will better meet his future cash needs.
