
ABOUT THE FUND

- The fund will not be biased towards any sector.


PORTFOLIO POSITIONING

- Industrials, Consumer Discretionary and Financials are key overweight sectors. Within Industrials, we have exposure to companies with strong technological advantage over peers. Our overweight stance on consumer space is reflective of expected uptick in consumption space in the second half of the financial year. We have increased weight in Financials during the month.
- We are underweight in IT Services and Healthcare. Our Underweight on IT Services is on account of uncertain global environment and tepid global growth outlook.
- The allocation to small cap companies is at 83%. Allocation to Mid and Large cap companies is 15%. Our cash position is 1.4%. (Exposure as % of net assets as on October 31, 2025).
- We follow the bottom up approach in small cap investing which is about identifying the champions of tomorrow.
