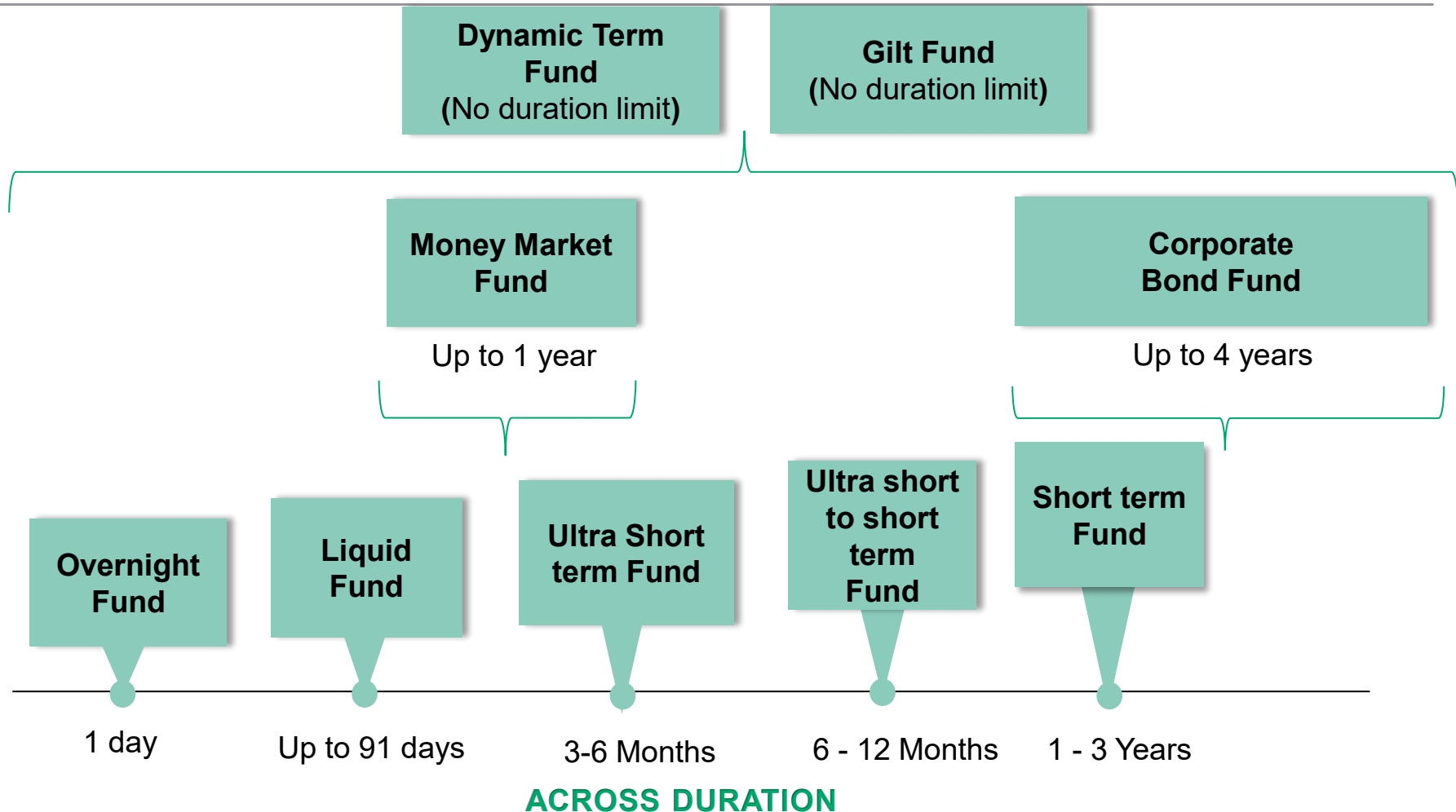

Fixed Income Markets Outlook

- **Q1 FY27 real GDP grew at 7.8%**, well above the RBI's 7.0% projection, providing strong domestic economic resilience.
- Strong growth has reduced the urgency for monetary easing, shifting the central bank's primary focus toward inflation control.
- The August MPC minutes turned hawkish, with markets now pricing in a **higher probability of an FY27 rate hike** over cuts.
- **July CPI inflation rose to 4.45%** and food inflation hit 5.52%, posing near-term supply-side risks to the 5% FY27 target.
- Special Foreign Currency Non-Resident (Bank) account facilities brought in **USD 136.377 billion in foreign inflows**, creating an abundant near-term banking liquidity cushion.
- Surplus liquidity caused the **3-month T-bill yield to drop 8 bps to 5.27%**, while longer maturities repriced higher.
- Mid-to-long yields climbed under policy pressure, pushing the **2-year G-sec to 6.28% and the 10-year benchmark to 6.95%**.
- The CD curve steepened, with **9-month and 1-year CD rates rising to 7.12% and 7.20%**, offering an attractive carry premium.
- **SDL-G-sec spreads are widest in the 1–5 year segment (62–64 bps)**, presenting selective yield pick-up opportunities.
- The **2–5 year segment offers the best risk-reward**, balancing defensive duration risk with optimal carry earnings.
- Sticky global rates, a hawkish US Fed, and Brent crude trading between \$80–\$95/bl continue to cap a rally at the long end.

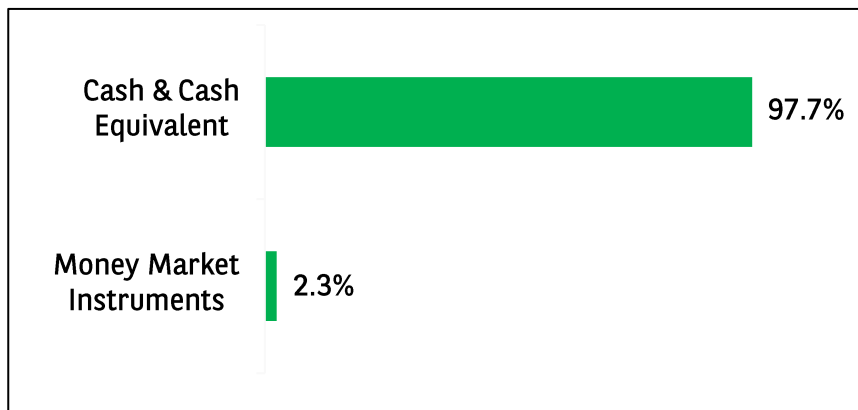
About the Fund

- It invests predominantly in TREPS (tri-party repo) and other debt securities with a maturity of one business day.

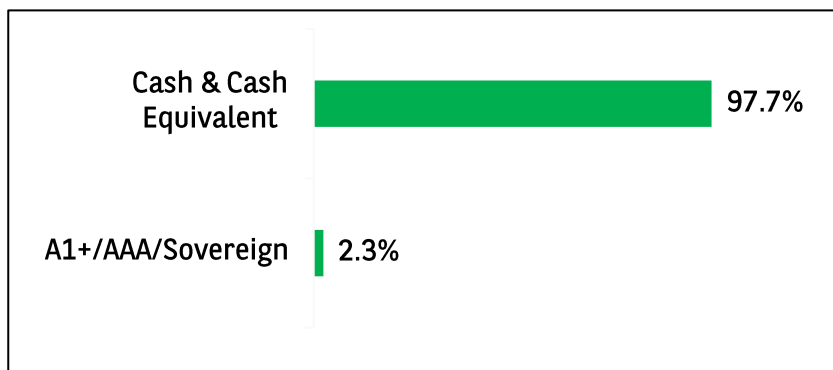

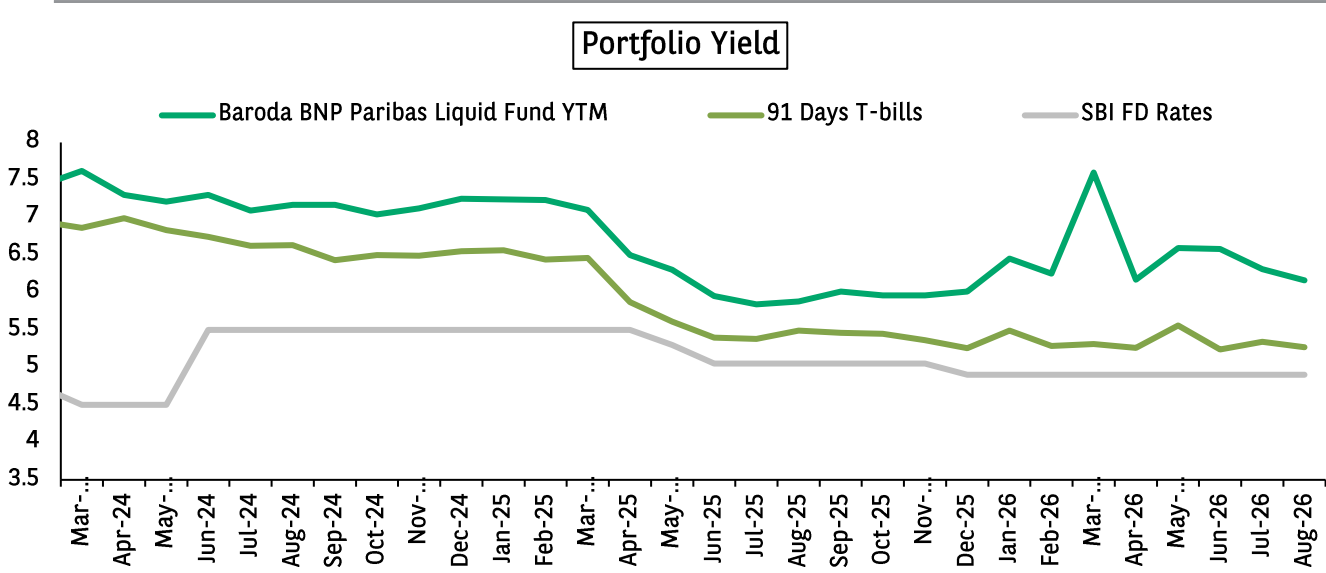

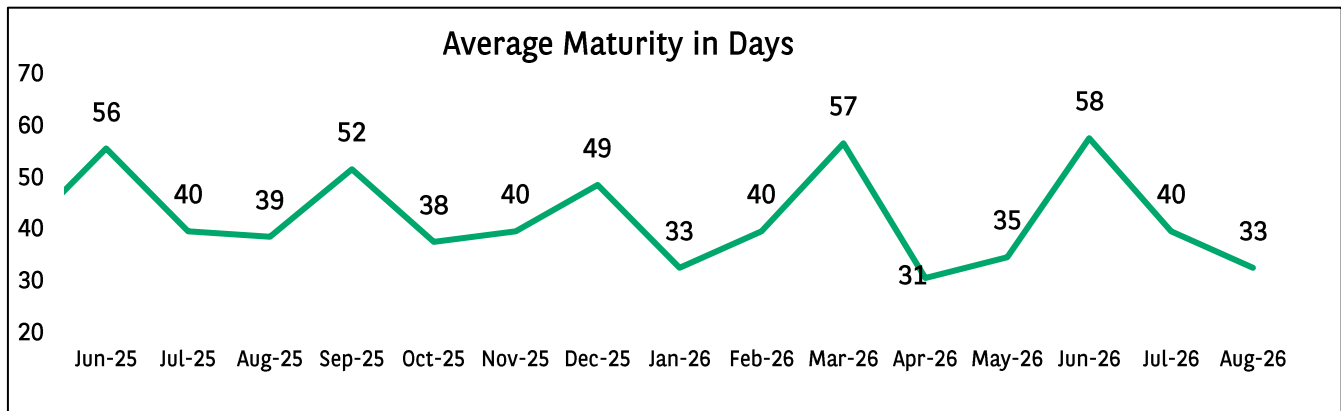
- Baroda BNP Paribas Liquid Fund invests in debt and money market instruments with maturity of up to 91 days only.
- The fund primarily invests in short term debt instruments including treasury bills, certificate of deposits (CD), commercial papers (CP), Tri-party repo (TREPs) on CCIL platform with Government Securities as collateral/reverse repos, etc.
- The scheme intends to maintain average portfolio maturity around 30-35 days and continues to remain invested in liquid assets, largely in Banks, Public Sector Undertaking/Private Finance Initiatives and a few select NBFCs.
- The Primary Supply in Certificate of deposits and Commercial Papers remain healthy.

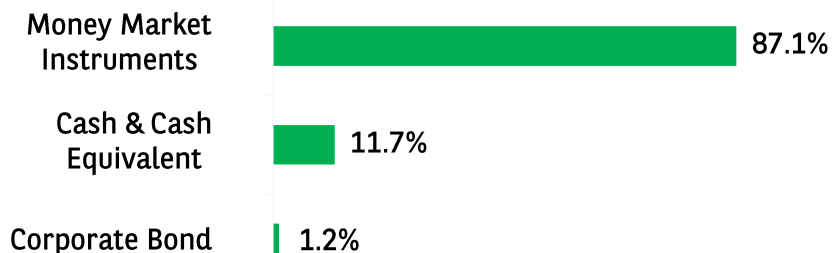


From the graph we may infer that the average maturity of the portfolio has also been consistently maintained at less than 2 months.

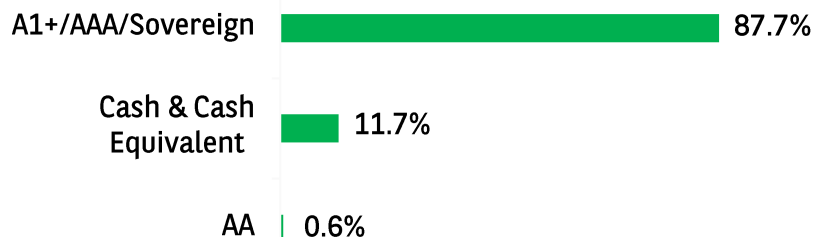

- We intend to keep the duration near to 1.8-2 years and the scheme remains open to taking tactical duration calls.

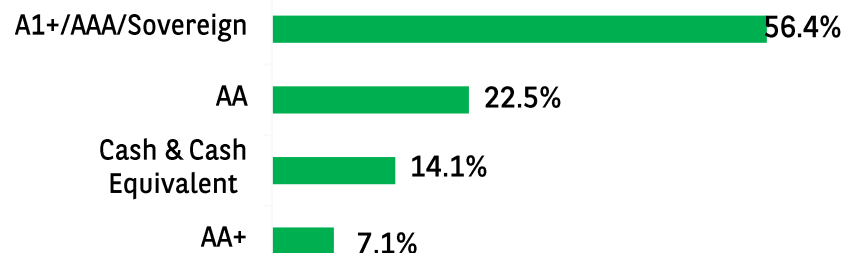

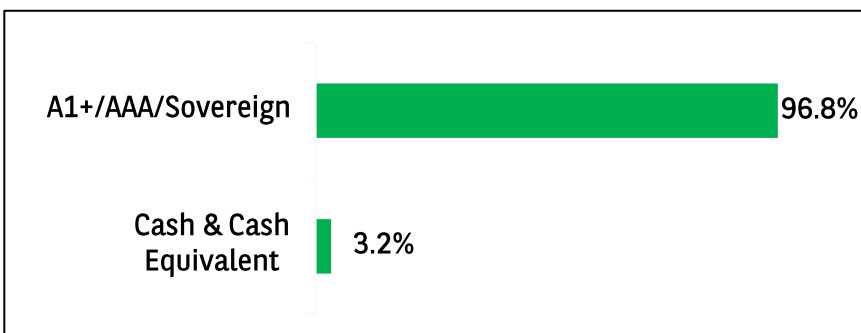

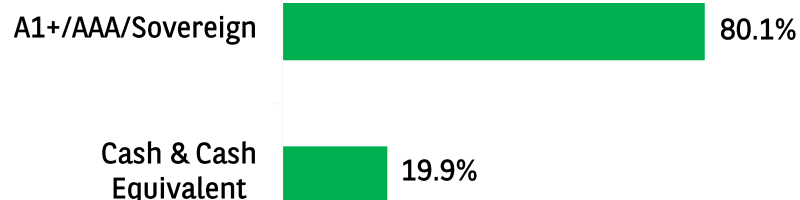
