MARKETS WITNESS A RELIEF RALLY

The benchmark Nifty closed at 15699 levels, up by approximately 2.65%. The Sensex closed at 52728 levels, up by approximately 2.66% for the week.

Macro-economic developments

The India Meteorological Department (IMD) on Thursday, 23 June 2022, said that the Southwest monsoon is likely to cover the entire country by 6 July 2022, a tad earlier than the normal date of 8 July 2022.

The INR edged lower against the USD to close at approximately 78.31 levels for the week.

In the commodities market, Brent crude for August 2022 settlement fell to close at approximately USD 110.31/barrel levels.

The yield on 10-year benchmark Government Securities paper fell marginally to 7.427% levels.
